Gentlemen:

In the matter of the application of Union Oil Company of California for determination of conditions and methods of operation to drill Jefferson Well No. 17RD from the controlled drilling and producing site located in the C2-1VL-0, R2-1-0 and RD1.5-1-0 Zones in Oil Drilling District #U-124, please be advised that pursuant to Section 13.01 F-17 of the Municipal Code, Union wishes to amend the conditions prescribed by the Administrator in Case No. ZA 17528 and 18236.

In addition to the conditions that have been waived pursuant to your letter dated April 1, 1994, Union hereby requests that the following conditions and methods of operations prescribed in Case No. ZA 17528 on April 29, 1965 be revised as follows:

Condition No. 1

Conditions 1, 43, 47 and 49 as set forth in Subsection F of Section 13.01 of the Municipal Code be deleted and condition 19 be added.

Condition No. 2

Condition to be modified to permit a 96 foot drilling derrick and a 10 foot subbase for a combined total height of 106 feet. In addition, temporary tanks and equipment required for drilling operations may extend above the enclosing fence or wall surrounding the drillsite.

Condition No. 5

Soundproofing shall be provided by enclosing the work area on the east, west and south sides, a minimum of 10'. Open areas necessary for ingress and egress are excluded from the soundproofing.

Condition No. 6

Delete in it's entirety.

Condition No. 11

Pumping unit type and configuration will be governed by Section 13.01 F 19 of the Municipal Code.

Condition No. 15

The amount of liability insurance shall be reduced to \$1,000,000.

Condition No. 19

Modified to allow production facilities as per Section 13.01 F 19 of the Municipal Code.
