As long as Seller or its successors and assigns shall use Seller's retained Jefferson Street Drillsite (Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 21, 22, 23, and 24, Block "G", Poole and Jones Tract) for oil and gas drilling and/or production purposes, Buyer and its successors and assigns shall retain the existing dwellings on said Lots 11 and 20, or suitable replacement thereof, in conformity with current zoning, building and health and safety codes, in order to serve as a buffer area between the Jefferson Street Drillsite and the Lots adjacent to the North of said Lots 11 and 20

Buyer and its successors and assigns shall agree that as long as Seller or Seller's successors and assigns shall own or operate the Jefferson Street Drillsite, said Drillsite and all operations conducted thereon will be permitted uses with the unconditional consent of Buyer and its successors and assigns Buyer shall acknowledge and agree that the operations of Seller or its successors or assigns may emit noxious odors and fumes, and may cause vibration, loud and continuous noise, safety hazards, unsightliness and/or extensive truck traffic. None of the foregoing matters, or any other operations of Seller or its successors or assigns on and in the Jefferson Street Drillsite, shall constitute any nuisance to or for Buyer or its successors, assigns or tenants. Furthermore, Buyer and its successors and assigns shall have the duty to disclose the terms and condition discussed in this paragraph, and elsewhere in this letter, to their future lessees tenants, residents or purchasers of all or any part of said Lots 11, 12, 19, and 20. Such disclosure shall be made in any lease, rental agreement, sales agreement or other agreement to be entered into by and between Buyer or its successors and assigns and any of their future lessees, tenants, residents or purchasers.

Upon the request of Seller or Seller's successors or assigns, from time to time, Buyer and its successors and assigns shall expressly consent to and approve in writing of the exercise and enjoyment by Seller and its successors and assigns of all their rights, title and interests in and to the Jefferson Street Drillsite including, without limitation, all operating and other appurtenant and incidental rights and interests under Seller's Conditional Use permit from the City of Los Angeles, as well as all operating and other rights and interests derived or permitted by and through the laws and regulations of the California Division of Oil, Gas and Geothermal Resources, Buyer and its successors and assigns further agree not to oppose or in anyway object to any application or attempt by Seller, its successors or assigns, to secure from any government agency or authority having jurisdiction any zoning exception, variance, permit, favorable land use classification or other authorization of any kind or nature desired by or required of Seller, its successors or assigns with respect to the exercise and enjoyment of any operations on and in the Drillsite

The foregoing provisions and/or Restrictions to be included in the deed or other conveyance from Seller to Buyer shall run with and be a burden upon said Lots 11, 12, 19 and 20 for so long as Seller or its successors or assigns shall use the Jefferson Street Drillsite for oil and gas drilling and/or production purposes, and until such time as the Jefferson Street Drillsite is abandoned and no longer used for such oil and gas drilling and/or production purposes
